Retention of this Contract on the part of the purchaser will be taken as evidence of acceptance. Society assumes no responsibility for the loss or damage of Lessee's property. Contract subject to Lessee securing license from Dept. of Agriculture of this State (if required).

INDEMNITY: The Lessee assumes liability for and shall indemnify, protect, save, and keep harmless the Lessor, its agents and servants from and against all losses, damages, penalties, claims, actions, suits, costs, expenses, and disbursements, including legal expenses of whatsoever kind and nature imposed upon, incurred by, or asserted against the Lessor in any way relating to or arising out of this lease or of the use of the equipment. The indemnities contained in this Section shall continue in full force and effect, notwithstanding the termination of this lease.

INSPECTION: The agents of the Lessor may, at anytime, inspect the property and the manner in which it is being used.

RETURN: At the end of the term of this lease, the Lessee shall return the property in the same state of condition as received, reasonable wear and tear expected.
